Ten-Step Work Plan

1. **Get organized**
2. **Develop initial GHG inventories and forecasts**
3. **Identify possible GHG mitigation policy options**
4. **Identify initial priority policy options for first round evaluation**
5. **Draft straw design proposals for draft policy options**
6. **Evaluate GHG reduction potential; costs or cost savings**
7. **Identify potential barriers to consensus, alternatives**
8. **Modify, add, or subtract policy options as needed**
9. **Evaluate cumulative results of policy options**
10. **Finalize emissions projections, recommendations, and report language**

- TWG facilitator presents proposed options
- Cover clarifying questions and comments
- Identification of objections, alternatives
 - If no objections, option is approved as final
 - If objections, PG discusses proposed alternatives and votes again if/as needed
 - Options not agreed to in full at this meeting will be referred back to TWGs and presented at the final GCCC-PG meeting

Updates to GHG Inventory and Reference Case Projections

- CA Low-Emission Vehicle Standards
 - Incorporated into reference case projections for 2009-2030
 - Change relative to prior baseline, lowers:
 - 2010 emissions by 0.3 MMtCO₂e
 - 2020 emissions by 0.9 MMtCO₂e
 - 2030 emissions by 1.3 MMtCO₂e
- Forest Soil Carbon Emissions
 - Removed from net emissions per recent discussions with US Forest Service (estimate is too uncertain)
 - Estimate for VT was -0.7 MMtCO₂e

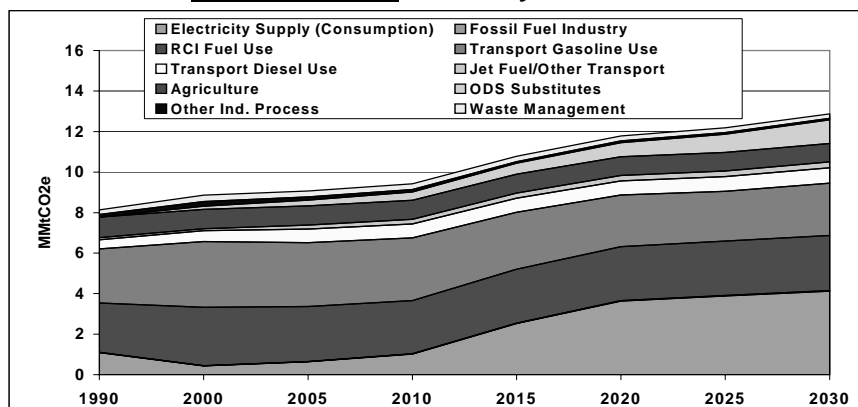

With System Average Electricity Mix Forecast



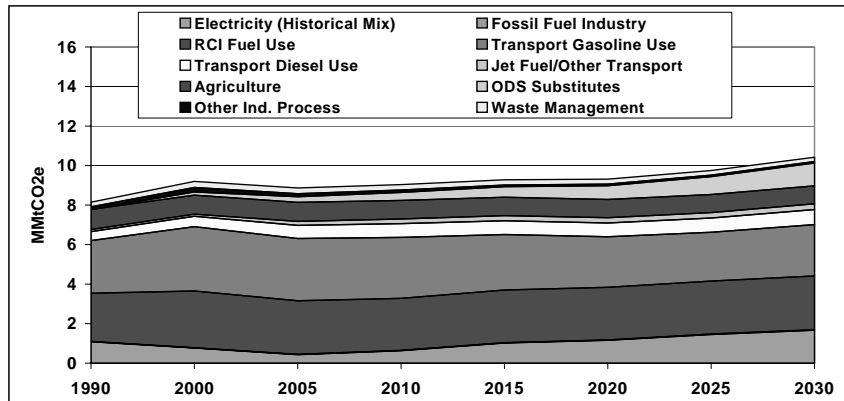

With Hypothetical Historical Electricity Mix Forecast

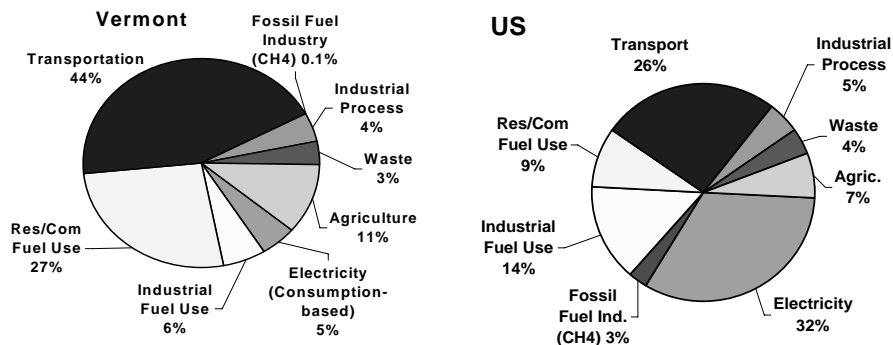

Vermont & US Emissions By Sector, Year 2000

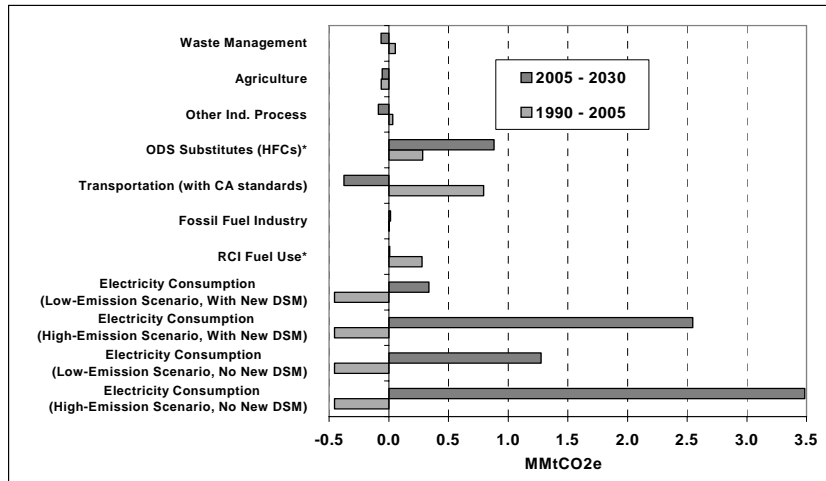

Vermont Emissions Growth

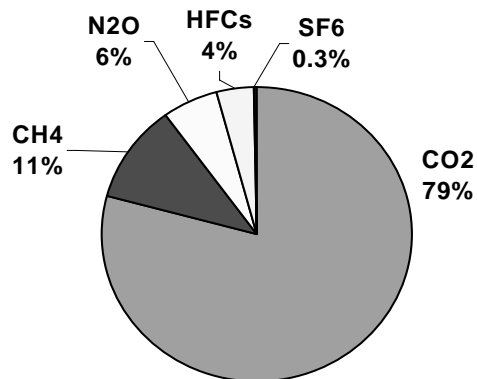

Vermont Emissions By GHG, Year 2000

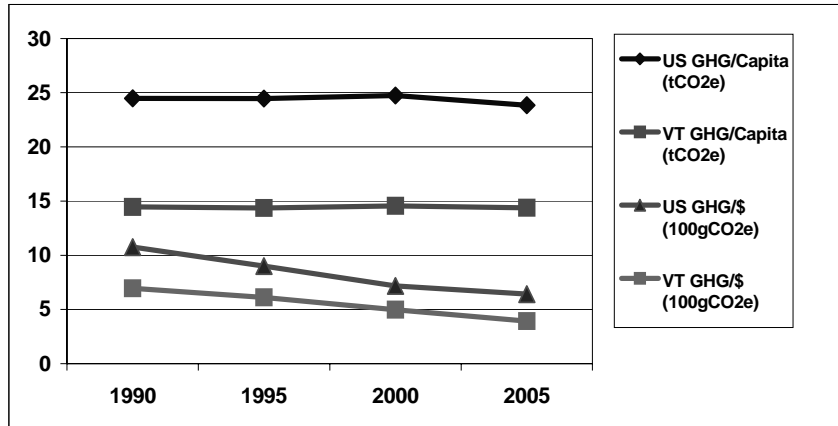

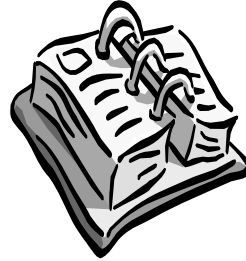
